- a. **Marjo Mello, Library Director,** thanked the City Council for dedicating the May 7th meeting in memory of her late husband Mike and also thanked her co-workers and public for their thoughts and prayers.
- b. **Ryan Kelley, County Board of Supervisor Chairman,** updated the City Council on their meeting with the International Boundary Water Commission about the New River. Part of their effort is to reach out to the Attorney General to help in the fight to clean the water to California standards. A request for a support letter which will be brought to the City in the near future.

The County is adjusting its budget. The County has used reserves and now has a hiring freeze and is taking measures to review all vacant funded positions.

a. Imperial Irrigation District Director Alex Cardenas re: AB 854.

Franks Oswalt, Attorney for Imperial Irrigation District, attended on behalf of IID Director Alex Cardenas. He provide an update regarding AB 854. The bill would add six Riverside County seats to IID's current board, which is made up of five members from Imperial County, drastically changing the composition to account for the district's Riverside County energy ratepayers, who make up 60% of IID's electricity customer base. The legislation is now suspended.

a. Discussion and Potential Action re: Modification of the Conditions of Approval for the Latigo Ranch (TM05-01) Major Subdivision Map, Submitted by Brawley Investment Ventures, LLC.

Staff Report - Rosanna Bayon Moore, City Manager

CM Bayon Moore stated that at the April 2nd City Council Meeting a number of topics were discussed by the City Council. A series of additional changes were considered. Since that time, the IID had the opportunity to meet and take action on a request that had been presented by the City of Brawley to IID to provide assistance with undergrounding of the Best Canal. On April 30th, the IID Board took action on a joint endeavor with the City of Brawley for a 75/25 match with the City for Phase II of the Best Canal undergrounding.

Marty Coyne, Brawley Ventures, LLC mentioned that he wanted to congratulate the IID. Everybody put forth a lot of effort to cover the public safety part. That was a major concern not only for the citizens but also the City Council. He stated he is ready to move forward and revitalize Latigo Ranch. This project will be a private public partnership in many ways. The most important part is bringing new revenue into Brawley in sales tax or revenue to your water and sewer plants after 12 years of blight.

Brooks Hamby, Brawley resident, stated that Brawley is a distinctive and unique community. Brawley has a 110 years worth preserving. He urged the City Council to be careful and thoughtful about how the City builds. What is built because is permanent and defines what this community of Brawley is and how financially sustainable the CIry will be.

Katie Luna, Brawley Chamber of Commerce Execute Director, commented and that while everyone has concerns strained resources at the Police and Parks Departments, growth cannot be hindered. Growth is going to happen one way or another. Unfortunately, the fiscal issues have taken years to develop with the budget affecting growth today. The issues are being correlated in a way they should not. Another point to consider is that if Mr. Coyne did not move forward with his development, the City's grant funded project would continue anyway.

CM Hamby said he wanted to clarify. There is good growth and bad growth. The fact that this is middle income housing so it will be property tax paying. That is a step in the right direction. Brawley has a lot of growth that is not paying property taxes and costs the City more than it brings in.

CM Bayon Moore mentioned that whoever the developer was in the future, the City's primary goal in grant seeking was to begin some leg of Wildcat because there has long been a desire to have Wildcat reach from HWY 86 to HWY 111. The ultimate goal for the City is to have an East/West corridor that runs the full length of the City. If the City had not undertaken the effort to secure a grant, the City would simply be waiting for a developer and the market to recover to a point that the improvements would be triggered as a result of the Conditions of Approval.

9. DEPARTMENTAL REPORTS

a. Update re Emergency Construction at the Brawley Water Treatment Plant to Replace Components of Two Sedimentation Basins, by Guillermo Sillas, City Engineer.

PWD Sillas reported that he is working on all documents to be signed and to start with the process of beginning construction.

CM Nava asked if it fails, can plant still deliver water.

PWD Sillas stated yes, the plant can deliver water but the quality might not be the same. Additional monitoring and sampling will be required and if the quality is lower than the required standards, issuance of a boil water order may be necessary.
