NOTICE AND INVITATION TO BIDDERS
CATTLE CALL DRIVE SANITARY SEWER SERVICE INSTALLATION

NOTICE IS HEREBY GIVEN that sealed bids for the Cattle Call Drive Sanitary Sewer Service Installation, will be received by the City of Brawley (City) in the offices of the City Clerk, 383 Main Street, Brawley, California 92227 until **2:00 p.m. Local Time, on June 5, 2014**, at which time they will be publicly opened and read aloud. No late bids will be accepted.

The Contract for the Cattle Call Drive Sanitary Sewer Service Installation will be awarded to the lowest responsible Bidder. City reserves the right to reject all bids, waive any irregularities or to dispense with further bidding.

BID BOND: Shall be completed in the forms provided as per Instructions to Bidders, **and** accompanied by a Certified Check, Cashier's Check or a Bid Bond executed in favor of the City of Brawley in an amount of ten percent of the bid, to be forfeited as fixed and liquidated damages should bidder neglect or refuse to enter into a contract.

PROJECT DESCRIPTION: The Work to be done consists of furnishing all materials, equipment, tools, labor and incidentals as required by the Plans, Specifications and contract documents. The work includes the installation of an 8-inch diameter PVC sanitary sewer pipe and fittings to extend an existing sewer service and connect to a sanitary sewer manhole. The work also includes the abandonment of an existing 8-inch diameter sanitary sewer service, installation of a new sanitary sewer clean out and demolition/construction of a concrete alley approach.

It is intended that the work be completed in every respect under the Contract, and such items or details not mentioned above that are required by the Contract documents shall be furnished, performed, placed, constructed, or installed by the Contractor.

CONTRACT AWARD: If a Contract is to be awarded, the City will give the successful Bidder a Notice of Award. The successful Bidder shall furnish to the City, within 10 days of receipt of such notice the fully executed Contract Agreement.

MANDATORY PRE-BID MEETING: A **Mandatory Pre-Bid Meeting** will be held to familiarize all interested bidders with the specifications. The meeting will convene at **10:00 a.m.**, at the **Department of Public Works, 180 South Western Avenue, Brawley, CA on May 28, 2014.**

LOCAL BIDDER PREFERENCE: The City has adopted a Local Bidder Preference Policy for the Award of Contracts. Specifics of the policy are included in the Special Conditions.

BIDDING DOCUMENTS: Bidding documents may be obtained from the office of the City Clerk, 383 Main Street, Brawley, CA 92227, (760) 351-3059 at a cost of \$25.00 (non-refundable) for each set of contract documents. Bidding documents will be mailed to bidder at bidder's request; however, the City will not be responsible for delays in mail delivery.
