RESOLUTION NO. 2021-54

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRAWLEY, CALIFORNIA, RECITING THE FACTS OF THE SPECIAL MUNICIPAL ELECTION HELD ON NOVEMBER 2, 2021 DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY LAW.

WHEREAS, a Special Municipal Election was held and conducted in the City of Brawley, California, on Tuesday, November 2, 2021, as required by law; and

WHEREAS, a notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the County Election Department canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BRAWLEY, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1: That the whole number of votes (ballots) cast in the precincts except absentee voter ballots were 938 and mail absentee precinct voters were 1,478; that the whole number of permanent mail ballot voters in the City was 6, early voting ballots casts were 23, making a total of 2,445 votes cast in the City.

SECTION 2: That the ballot measure results are as follows:

Measure U — as a result of the election, a majority of the voters voting on the measure relating to extension of the 4% Utility Users Tax without a sunset did vote in favor of it and that the measure was carried, and shall be deemed adopted and ratified.

SECTION 3: That the number of votes given at each precinct and the number of votes given in the City and the votes for and against the Measure are listed in Exhibit "A" attached hereto and made a part hereof:
