RECOMMENDATION:

Approve the American Rescue Plan Act Spending Plan and budget as modified and direct staff to continuing providing progressive updates every six months until all funds are spent.

BACKGROUND INFORMATION:

On March 11, 2021, the American Rescue Plan Act 2021 (ARPA) was signed which launched the Coronavirus State and Local Fiscal Recovery Funds (SLFRF) to provide \$350 billion in nationwide emergency funding for state, municipalities, counties, tribes, and territories. Of the \$350 billion, the City of Brawley will receive \$6,274,056 in one-time funding. Funding will be received in two equal disbursements of \$3,137,028 with the first payment received in July 2021 and a second payment expected in July 2022.

The emergency economic stimulus bill provides fiscal aid to address the ongoing COVID-19 public health crisis. ARPA provides funding to meet local needs, including COVID-19 response, replacing public sector revenue loss, premium pay for essential workers, improving facilities to ensure health and safety, increase usage of outdoor spaces, as well as investing in public water and wastewater infrastructure and broadband. Each agency has the flexibility to determine how to best use fiscal recovery funds to meet their needs.

On December 21, 2021, the City Council approved a plan for the City's ARPA funds and staff agreed to provide an update every six months on the progress and any recommended changes to the plan. Projects and estimated cost are detailed in Attachment 1. Public meetings are a time to collect public input on the use of these one-time funds. Planned uses may be amended based on public input, cost savings, or newly identified needs. Most expenses must be spent by December 31, 2024. Water and wastewater infrastructure improvements can be spent by December 31, 2026.

Since December 2021, three items highlighted in green have been completed. Sixteen initiatives highlighted in yellow are underway and have made significant progress.

FISCAL IMPACT:

The City has received all ARPA Funds allocated totaling \$6,274,056. Expenses were originally budgeted in FY 2021/22 when the ARPA plan was created, savings were carried forward to FY 2022/23 and any amendments to reallocate funds between expense line items are based on quarterly updates.

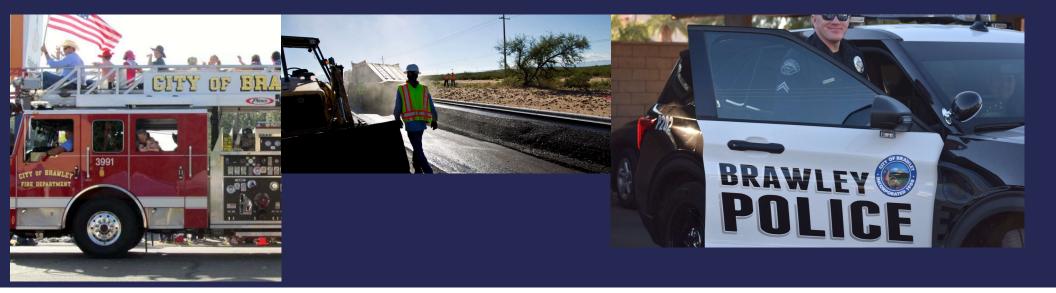
