## RESOLUTION 2025-

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BRAWLEY, CALIFORNIA APPROVING AN OPERATIONAL AGREEMENT BETWEEN THE IMPERIAL COUNTY DISTRICT ATTORNEY'S OFFICE VICTIM WITNESS ASSISTANCE PROGRAM AND THE BRAWLEY POLICE DEPARTMENT

WHEREAS, the Brawley Police Department (BPD) and the Imperial County District Attorney's Office Victim Witness Assistance Program (VWAP) recognize the importance of providing maximum available assistance for crime victims residing in Brawley; and

WHEREAS, VWAP and BPD shall make mutual referrals as appropriate; and

WHEREAS, BPD will refer victims to the VWAP by providing victims with contact information or by directly contacting VWAP by phone or email to request assistance; and

**WHEREAS,** VWAP personnel will be readily available to the BPD for service provisions through direct referral of all victims of crime; and

**WHEREAS**, VWAP personnel shall provide training to law enforcement on services available to crime victims as needed; and

**WHEREAS**, regularly scheduled meetings between BPD representatives and the Program Director of VWAP while participating on the Child Abuse Response Team, Sexual Assault Response Team, and Death Review Team; and

**WHEREAS,** the VWAP staff shall be available to the BPD at 940 W. Main Street, Suite 102, El Centro, CA 92243.

NOW, THEREFORE, BE IT RESOLVED, THE CITY COUNCIL OF THE CITY OF BRAWLEY, CALIFORNIA, HEREBY:

APPROVES THE ACCEPTANCE OF THE MEMORANDUM OF UNDERSTANDING BETWEEN THE IMPERIAL COUNTY OFFICE OF EDUCATION AND THE CITY OF BRAWLEY AND;
