- Annual Hangar Inspections Fire Marshal Rodelo Have performed 36 hangar inspections as of April 11, 2025.
 25 hangar renters did not comply with the annual hangar inspection, and will check with legal. Co-Chair Kern requested the cutting of non-city locks proceed.
- Crack Fill, Slurry and Stripe project Medina stated the RFP is moving slowly will be issued for project in a few weeks, and will be given 60 days to complete. Has assigned design work for the projects to AE Consulting, but is waiting for the cost estimate.
